## VT2/4/8 Vapour Tight Fixtures Installation Instructions

## SURFACE MOUNT INSTALLATION

- 1. Use the provided mounting screws to secure the Surface Mounting Brackets to Mounting Surface (Fig.1). See Table 1 for the recommended Surface Mounting Bracket distance from center to center.
- 2. Attach the back of the luminaire's housing into the mounting brackets (Fig. 2). Ensure the LED tray is secured with the safety tethers. Unlatch the Lens and Tray Assembly from Housing (Fig. 3).
- 3. Install the cable gland to the end of the housing. Insert the flexible power cable (not included) through the cable gland allowing for sufficient length of stripped cable inside the housing and tighten the gland. Insert supplied plug into unused conduit hole.
- 4. Make electrical connections (see wiring instruction on reverse).
- 5. Secure the lens and tray assembly to housing by clamping down the latch.
- 6. Fasten and secure lens cover using latches (Fig. 4).
- 7. Restore power to the luminaire (Fig. 5).

### SUSPENSION MOUNTING INSTALLATION

- 1. Secure Surface Mounting Brackets to Housing (Fig.6).
- 2. Install the V-Hook on Surface Mounting Bracket (Fig.6).
- To suspend Housing, connect each V-Hook to two equal lengths of chain (not supplied) and/or appropriate hardware suitable for mounting surface. Chains must be suitable to support four times the weight of the fixture.



## WIRING INSTRUCTION

Make the necessary wiring connections as shown in the wiring diagram (Fig. 7).

Cap the 12V+ and GND if the sensor is not used.

The polarity of the dimming connections is important to ensure the performance as desired.

If not using the dimming functionality, DO NOT connect the Driver Dim+ (Purple) and the Driver DIM- (Pink). Please cap the DIM wires if not in use.
